

CUMING COUNTY BOARD OF SUPERVISORS- 2011

DISTRICT #1 – is comprised of the part of the city of West Point lying East of 17th Rd/US Highway 275, South to 13th Street; the part of the city of West Point lying North of 13th Street, East to Colfax Street; the part of the city of West Point lying East of Colfax Street, South to Sherman Street; the part of the city of West Point lying North of Colfax Street, East to Grove Street; the part of the city lying North of Grove Street, East to County Road 18; the part of the city of West Point lying West of County Road 18, North to the West Point city limits at Washington Street; District #1 then follows the East city limits of West Point to 17th Road/US Highway 275.

DISTRICT #2 - is comprised of all of Bancroft Township (including the City of Bancroft), Cleveland Township, Logan Township, Neligh Township and Sections 1, 2, 3, 4, 5, and 6 of Garfield Township.

DISTRICT #3 - is comprised of the part of the city of West Point lying West of 17th Rd/US Highway 275, South to 13th Street; the part of the city of West Point lying South of 13th Street East to Colfax Street; the part of the City of West point lying West of Colfax Street, South to the Southwest City Limits of West Point; District #3 then follows the West city limits of West Point to 17th Rd/US Highway 275.

DISTRICT #4 - is comprised of all of Blaine Township, Grant Township, Beemer Township (including the Village of Beemer), Sections 1, 2, 3 and the North half of Sections 10, 11 and 12 in Elkhorn Township, Sections 5, the part of Section 6 Northeast of the Elkhorn River, the Northeast part of Section 7 bounded by the Elkhorn River to the Southeast, 8 and the part of Section 17 North of the Elkhorn River in Sherman Township.

DISTRICT #5 - is comprised of all of Cuming Township, Garfield Township (excluding Sections 1, 2, 3, 4, 5 and 6), Sherman Township Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, the Northeast part of Section 16 bounded by the Elkhorn River to the Southeast, the Northeast part of Section 21 bounded by the Elkhorn River to the Southeast, Sections 22, 23, 24, 25, the part of Section 26 not in the City limits of West point, the part of Section 27 not in the City Limits of West Point, and Section 36. The part of the city of West Point lying South of Grove Street, West to Sherman Street; the part of the city of West Point lying South of Sherman Street, West to Colfax Street; the part of the City of West Point lying East of Colfax Street, South to where Colfax joins US Highway 275, South to the South city limits of the city of West Point. District #5 then follows the Southeast city limits of the city of West Point, North then West to Beemer Street, North to State Highway 32/ County Road G, then West on State Highway 32/County Road G.

DISTRICT #6 - is comprised of Wisner Township (including the city of Wisner) and the part of city limits of the city of Wisner that lie within Sections 6 and 7 of Beemer Township.

DISTRICT #7 - is comprised of all of Bismark Township, Lincoln Township, Monterey Township, Elkhorn Township (excluding Sections 1, 2, 3 and the North half of Sections 10, 11 and 12), St. Charles Township, Sherman Township including the part of Sections 2 and 34 that lie outside the city limits of West Point, the part of Section 35 bounded by State Highway 32/G Road to the North, Beemer Street to the West and the city limits of West Point to the South and (excluding Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 21, 22, 23, 25, 27, and 36).
